CONDITIONS OF ENTRY

1. All art works must be the original work of the artist entering.
2. Artists must have an experience of mental illness or be a carer or family member of someone who has mental illness.
3. Artworks may be in the form of paintings, drawings, photographs or mixed media sculpture.
4. Art works must be framed, mounted and ready for hanging.
5. Each artist may submit a maximum of 2 art works, as space is limited.
6. Each art work must be clearly labelled on the back of the artwork with:
The name of the artist, title of the art work and must include the entry form.
7. Dimensions of works must be included on entry form: Height, Width, and Weight (especially for sculptures). We are unable to accept art work that is greater than A3 size or heavier than 5kgs.
8. In the event that the art work is deemed not suitable or does not meet the criteria, TeamHEALTH reserve the right to exclude the art work from the exhibition.
9. Art works are to remain on display for the duration of the exhibition, which commences on Monday 21 May and concludes on Friday 25 May 2018.
10. Art work will be voted on a people's choice voting system, which will run throughout the exhibition time period.
11. Prizes will be awarded to those art works that receive the top three votes collectively.
12. The artist must collect their art work from the venue following the closure of the exhibition on the 25th May or from TeamHEALTH Day to Day Living, after May 25 and prior to May 28. It is not the responsibility of TeamHEALTH to return art works.
13. TeamHEALTH will take all reasonable care, but no responsibility will be accepted for loss or damage.
